Additionally, MSPs are heavily pressed to be GDPR-compliant themselves; they have access to systems and devices storing personal data of their clients' customers. As both controllers and processors, engaging with and servicing their clients, MSPs must ensure their own compliance to avoid being at risk for fines.

Demonstrating MSPs' own GDPR compliance continues to have a real and direct impact on MSP business engagement. Keepabl founder and CEO Robert Baugh points to Cisco's <u>2019 Data Privacy</u> Benchmark Study that shows 87% of organisations are facing sales delays resulting from privacy concerns. MSPs can accelerate managed services contract signatures by weeks if they have provable GDPR compliance in-place – and, of course, ensure their clients have the right data security procedures and solutions activated.
