

CEX.IO BROKER to Go Live in 194 Countries for Leveraged Trading

London, England, April 3, 2019 — As soon as CEX.IO BROKER receives its broker license from EU jurisdictions, it will become available in 28 EU countries for Live Trading. A full launch in the US and Canada is scheduled for 2020. As of now, EU, US, and Canadian users can use Demo accounts to improve their trading skills.

CEX.IO BROKER, a multinational CFD trading platform, has taken the best from traditional trading markets and added its own innovations. CFD trading, or a "Contract for Difference", is a financial trading instrument under which no physical ownership of assets takes place. In other words, no transaction with underlying assets is made.

Building on over five years of experience in cryptocurrency trading of the CEX.IO exchange, CEX.IO BROKER is a functional trading tool that meets the needs of demanding traders from the traditional financial market as well as cryptocurrency fans.

Currently, CEX.IO BROKER supports only BTC deposits and withdrawals for customers residing in covered countries. The supported trading pairs are BTC/USD, BTC/EUR, ETH/BTC, ETH/USD, and ETH/EUR. Customers can deposit BTC directly to CEX.IO BROKER or transfer funds from a CEX.IO wallet. Deposits from a CEX.IO account are instant and commission-free.

"CEX.IO BROKER is backed by our cryptocurrency exchange, so customers can instantly purchase Bitcoin on CEX.IO and transfer it to a CFD account. After trading, verified customers can transfer BTC with the help of our crypto exchange to their external wallet. We offer customers a convenient way to start trading cryptocurrencies easily with leveraged trading opportunities via CFD instruments." — Elaine Neal, Chief Product Officer at CEX.IO

CEX.IO BROKER combines the best features from CFD trading, margin trading, forex trading, and other multi-asset trading solutions. Customers have access to a wide range of trading options, including 1:2, 1:3, 1:5, and 1:10 leverage depending on the market and jurisdiction.

"Most importantly, we offer a familiar interface for forex traders who use the MetaTader and CTrader platforms. Among other features of our new platform, I would mention the variety of trading tools; support for popular types of orders including market, limit, stop, and OCO; the opportunity to create several accounts for the same currency; the ability to use separate accounts for different strategies; and technical analysis, including a wide range of indicators and tools for drawing visual charting effects." — Elaine Neal, Chief Product Officer at CEX.IO

CEX.IO BROKER was developed in cooperation with Devexperts, veterans of conventional trading software. Among their projects are thinkorswim, a B2B trading platform for Alpha Capital Markets, and Gediktrader. The initial task was to create a platform that would combine margin trading with crypto trading functionality.

"Considering the ambitious task, we decided to use dxTrade, our flagship platform, so that it complies with the specifics of crypto trading. dxTrade is a multi-asset trading solution that can be adapted to a client's existing infrastructure. The Devexperts backend is responsible for order execution, including sending out offset orders, receiving quotes via the FIX gate, and facilitating deposits and withdrawals. User onboarding and settings management are done via REST API integration." — Michael Babushkin, CEO of Devexperts

The entire process of developing this product took about five months. It's a complex solution that adapts most of the components from the dxTrade platform and effectively applies them to cryptocurrency trading.

Due to regulatory conditions, CEX.IO BROKER is currently available in two versions: Demo Accounts and Live Trading. Clients from covered markets can use all Live trading opportunities. Customers from the US, UK, and EU are currently able to use only Demo accounts. As soon as Live Trading is extended to additional countries, a special announcement will be made.
