- 9. Deferring mortgage payments
- 10. No fees or penalties for missing rental payments
- 11. Protection from utilities being shutoff during the coronavirus

These reliefs are only the start and it is anticipated that further help will be provided. If the current financial crisis continues, it is likely that the \$1,200 stimulus check is just a first in what may be a recurring amount through the summer.

The relief guides also provide links to check what support is being offered by each state.
