Tom will continue as a trustee on the Flat Spaces Board and has joined the SCiA Group Board of Trustees.

Flat Spaces enable those with severe disabilities to take a holiday, in the full knowledge and confidence that their needs will be catered for. They have a spacious three-bedroom bungalow for hire in Hampshire that is fully equipped, in a beautiful location, and close to local attractions. Flat Spaces enables everyone to enjoy an accessible holiday, resulting in improved mental health and wellbeing for visitors and their families as a result of the break.

Chairman of SCiA Trustees' Edward Hickman, who has been a trustee for eight years and Chair of the Trustees since March 2022, says: "Flat Spaces have a fantastic track record supporting people with disabilities and their carers to take a holiday that is accessible, safe in the knowledge that their needs will be catered for.
