

## Fusion announces Lovett's Accountants Acquisition

**LONDON – 3<sup>rd</sup> July 2023**—London Based Professional Services Group acquires Lovett's Accountants, completing its 5th acquisition of 2023.

Mitch Young and Adam Maurice formed Fusion Consulting in 2015 to cater for the Private Client and SME sectors, providing a broad range of services including International Taxation, Business Advisory, Accounting, Financial Services, Legal Services, Recruitment and Digital Marketing.

The Lovetts client base will now benefit from being able to tap into a broader range of skills and experience whilst continuing to retain the personal relationships built directly with the existing team.

As part of this transaction, Fusion has also acquired HBB Audit Limited, which adds Audit and Assurance services to the Fusion service offering.

Adam Maurice, Director of Fusion said: "I am delighted to announce our latest acquisition. Lovetts has a well established client base which will benefit from our 360° advisory services and I am very pleased to also announce Chris Garbett's promotion to Head of Fusion Accountancy – Hatfield. I look forward to welcoming Chris, Paul and the rest of the Lovetts team into the group."
