## Simple, guided health and safety system

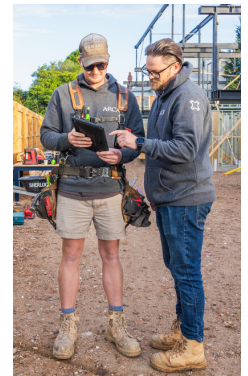
