He is a people-first leader and has built the new organization based on purpose, performance and culture. Having successfully completed the first phase of our integration and managed the impact of COVID-19 this year, Jason is leaving an incredible legacy.

Jason will remain as Global CEO until 1 April 2021 and will then work closely with his successor for three months to ensure a seamless handover. NTT will be announcing Jason's successor in the coming weeks.
