

# Learn lessons from the military as major online underwriting event tackles cyber

Over 80 percent of those currently signed up for the event are from insurers.

Topics covered include the evolving cyber risk landscape and how to support clients to achieve resilience through product innovation; how to use COVID-19 to drive home changes in the cyber coverage space; how to find a path to profitable cyber underwriting through data and analytics; and new tactics for accurate cyber risk assessment.

Keynote speaker Judy Chow, Director of Product Management, CyberCube, said: "You need only to open the news on any given day to be reminded of the explosion of cyber threats challenging businesses across the globe.
