

## Lee Dentith Steps Down as Media Agency Group CEO

Having founded Now Healthcare Group in 2014, Dentith has seen the healthcare organisation grow exponentially. Now working with a customer base of over one million users, he feels the time is right to step away from his role at Media Agency Group and fully concentrate his efforts on the mobile health sector. "The last few months have seen Now Healthcare Group grow to become Europe's clear market leader in the fast-moving mHealth industry, and as a result I feel it is time to step back from my position at Media Agency Group and hand over the reins to John and his team. I'm incredibly proud of what the company has achieved under my leadership and I am delighted to be continuing my involvement with the agency as a non-executive chairman."
