In schools specifically, recent figures show that on 21 July, 5.5% of teachers and school leaders and 5.1% of teaching assistants and other staff were absent for any reason from open schools — painting a And Reimbursement Framework clear picture of ongoing disruption in the education workforce DfE, 2022.

This mounting pressure is also reflected in the 2023 School Workforce Census, which reports:

- 468,700 FTE teachers in state-funded schools, up only slightly from last year
- 282,900 FTE teaching assistants, up by 1,800
- A 20% increase in teacher vacancies from 2022 to 2023
- · A continuing rise in pupil-to-teacher ratios, especially in nurseries and primary settings
- · The highest number of temporarily filled posts in recent years

These figures paint a stark picture of the growing demand for dependable absence protection and staff wellbeing services in schools.
