The acquisition, which will be effective from 11 December 2014, will mean that the independent planning practice, with a team of 18, will increase Carter Jonas' London planning and development team to 33 people; all based in One Chapel Place, the firm's West End headquarters.

Its national service is provided through a network of 32 offices across England and Wales, with planning & development teams in London, Oxford, Cambridge and Harrogate. It now has some 75 chartered planners and surveyors in these offices, making it one of the largest teams in the UK.
