By adopting this new business strategy the companies will ensure they achieve the highest monetisation possible.

### New Partnerships Are Highly Possible

Sontax Ltd. do not discount the possibility to enter more partnerships in the future since their goal is to expand their business and collaborate with major players on the Asian gaming market also. The increasing number of mobile users who have visited their latest website for live roulette makes them very optimistic that further innovations in their mobile software will soon take place. Dominic Fitz shares that their next goal will be to team up with an Asian software development company and focus on designing a special native app that is intended only for Asian players.
