Newly approved foster carers with CFT will receive:

- **£750 upon approval**
- **An additional £750 after their first placement**
- **Up to £3,000 for experienced foster carers who transfer to CFT**

In addition to financial incentives, foster carers with **The Children's Family Trust** benefit from:

- **An in-house psychotherapist** providing direct support for carers and children
- **Full mileage reimbursement**, including for everyday short trips
- **Extensive local support** from dedicated fostering teams
- **Regular pay reviews** and a commitment to reinvesting **85p of every £1** back into fostering services
- **Recognition schemes** that celebrate the growth and achievements of looked-after children
