Who are the CAADV and what do they do?

CAADV combats domestic violence in 5 ways:

- Raising awareness throughout the workplace

- Giving access to HR policies which can set up a proper infrastructure for supporting victims
- Sharing knowledge and experiences

The Corporate Alliance Against Domestic Violence is a nationally recognised membership charity working with employers to address the impact of domestic violence in the workplace. The vision of CAADV is to work with every employer to respond effectively to domestic violence. The collaborative work with employers throughout the country has not only saved lives and addressed the needs of employees who endure, perpetrate and witness violence, but has also successfully assisted the reduction in the calculated cost domestic violence has to the UK economy. The Alliance is the only UK business to business specialist charitable consultancy working with employers.

Domestic abuse is a major problem which can affect every aspect of an endurers life, whether they're at home, at work, with friends or family.

The Cost

The cost of domestic abuse is both human and economic.

- In 2011/12, 7.3% of women (1.2 million) and 5% of men (800,000) reported having experienced domestic abuse – the true number of victims probably exceeds this (statistics from Women's Aid)
- 14% of all violent crime is domestic abuse and approximately 21 men and 104 women die each year (statistics for men from The Guardian, women from Women's Aid)
- According to the CAADV, the cost of domestic violence to UK business can be calculated at £1.9 billion
- NHS research shows the cost to them is estimated at £1.4 billion

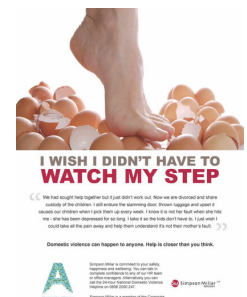
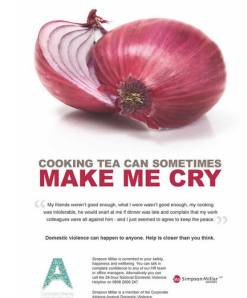
