# WATSON Releases New Survey Questionnaire Aimed at SMEs

The WATSON project is now inviting innovative SMEs to take part in research which examines the effects of Research and Development (R&D) Tax Incentives on SME innovation in Europe and whether R&D tax relief is an effective stimulator of innovation in Europe. It aims to influence policy surrounding R&D tax relief and incentives across Europe.

The results of the project will also allow the development of an integrated ICT platform to perform data analytics on innovation funding, identify funding gaps and enable the provision of advice for stakeholders (public governing bodies, SMEs, private investors, representative bodies, etc.) on the management of innovation and funding schemes. WATSON is a research project funded by the European Commission under the Horizon 2020 Programme. It aims to develop and demonstrate a framework methodology for studying the impact of R&D tax relief and incentives on SME-led innovation within Europe. The project has a duration of 18 months (January 2018 – June 2019) and a total budget of nearly 1 Million euros. It brings together six partner organisations comprising leading European academic research institutions and innovative SMEs from the domains of fintech, financial services and economics. The consortium is led by the UK innovative SME Kapitalise Ltd with partners from Exodus, Inventya, London School of Economics, Imperial College and Maastricht University.
