In Romania, the company works with several leading iGaming platforms, where its technology has contributed to up to 45% fewer fraudulent cases and over 30% higher retention among verified users, building a reputation of a trusted KYC provider in one of Europe's most dynamic markets.

Maksim Karandashov, Co-founder and CTO of X-faces, added: "Fraud prevention today requires continuous learning. Our systems evolve in real time, using AI to recognise new risk patterns before they impact the business."
